These circulars inter-alia stipulate penal action of imposition of fine of Rs.1000/- per day per complaint for non-resolution of investor complaints and subsequent freezing of promoter(s) holding. You may also please refer to the Exchange notice No. 20200818-7 dated August 18, 2020 & Exchange notice No. 20201026-6 dated October 26, 2020. You are requested to take note of the contents of the said SEBI circulars and comply.
