The 28th Annual General Meeting of the Equity Shareholders of M/s Capfin India Limited held on 27th September, 2020 at 12:00 noon through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM") as per Section 108 read with Rule 20 of Companies (Management and Administration) Rules, 2014

- I, Mr. Deepanshu Bansal(FCA:526717,FRN : 026196N), Company Accountant in Practice was appointed as Scrutinizer by the Board of Directors of Capfin India Limited (the "Company") on 25th August, 2020 to scrutinize the e-voting process in a fair and transparent manner and also for ascertaining the requisite majority on e-voting carried out as per the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 on the resolutions contained in the notice of the 28th Annual General Meeting ("AGM") of the Company, to be held on September 27, 2020 at 12:00 noon through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM")
- 2. The Company has engaged Central Depository Services (India) Limited ("CDSL") as the Service Provider for extending the facility of electronic voting to the shareholders of the Company. The Service Provider provided a system for recording the votes of the

- 2. The Company has engaged Central Depository Services (India) Limited ("CDSL") as the Service Provider for extending the facility of electronic voting to the shareholders of the Company. The Service Provider provided a system for recording the votes of the Shareholders electronically on all the items of business (both ordinary and special business) sought to be transacted in the 28th Annual General Meeting (AGM) of the Company, which is scheduled to be held on Sunday, the 27th September, 2020. The Central Depository Services (India) had set e-voting facility on their website, <u>https://www.evotingindia.com</u> The Company has uploaded all the items of the business to be transacted on the website of the Company at www.capfinindia.com and also it's Service Provider to facilitate their shareholders to cast their vote through e-voting.
- 3. As on the cutoff date there were 321 shareholders of the Company. The Notice was sent through email id to 138 shareholders whose email id was made available by the two depositories.
- 4. Pursuant to the Applicable Circulars, the Notice sent through email contained the detailed procedure to be followed by the shareholders to cast their votes electronically.
- The cutoff date (Record Date) for the purposes of identifying the Shareholders who will be entitled to vote on the resolutions placed for the approval of the shareholders was 20th September, 2020.
- 6. Pursuant to Rule 20(4)(v) of Companies (Management and Administration) Amendment Rules, 2015, the Company also released as advertisement, which was published on 7th September, 2020 in Financial Express, English newspaper and in Jansatta, in Hindi newspaper. The notice published in the newspaper carried the required information as specified in Rule 20(4)(v) (a) to (h).
- 7. Particulars of all votes cast by electronic mode have been entered in the register separately maintained for the purpose in electronic mode.
- 8. At the 28th Annual General Meeting of the company held through VC/OAVM, on Sunday, 27th September, 2020 after considering all the items if the business, the facility to vote electronically was provided to facilitate those members who were attending the meeting through VC/OAVM but could not participate in the Remote E-voting to record their votes.
- 9. Thereafter, the Remote E-voting and e-voting by the members at the AGM, results were unblocked by me on 28th September, 2020 on the CDSL e-voting platform and downloaded the results after the annual general meeting of the company pursuant to Rule 20(4)(xii) of the Companies (Management and Administration) Amendment Rules, 2015. After unblocking the votes cast, the total votes cast both through e-voting and by voting through

electronic means at the annual general meeting, were consolidated and the final Scrutinizer's Report was prepared.

Responsibility of the Management
