## लापता, पुलिस तलाश में जुटी बरेली, 2 सितंबर (जनसत्ता)।

घास काटने गए तीन बच्चे

थाना हाफिजगंज क्षेत्र से जंगल में घास काटने गए तीन बच्चे लापता हो गए हैं। थाना प्रभारी निरीक्षक चेतराम वर्मा ने बताया कि गुमशुदगी का मामला दर्ज कर पुलिस लापता बच्चों के परिजनों के साथ उन्हें ढूंढने में जुटी है। लेकिन 24 घंटे से ज्यादा समय बीत जाने के बावजूद उनका कोई सुराग नहीं मिला है।

थाना हाफिजगंज की पुलिस से मिली जानकारी के मुताबिक चेनामुरारपुर गांव के रहने वाले हिमांशु यादव (14), अनुज शर्मा (12) और सुरेन्द्र यादव (13) दो साइकिलों से मल्लपुर के जंगल में घास काटने के लिए शुक्रवार को सुबह के समय गए थे। देर रात तक उनके वापस न लौटने पर परिजनों ने पहले तो उन्हें खुद तलाश किया और बाद में इसकी सूचना पुलिस को दी है। थाना प्रभारी निरीक्षक चेतराम वर्मा ने बताया कि जंगल की ओर जाने वाले रास्ते की सड़क पर लगे सीसीटीवी कैमरों

की फुटेज की जांच करने पर सिर्फ एक स्थान पर जंगल की ओर जाते हुए तीनों बच्चे एक साथ दिखाई दिए हैं। उसके बाद उनकी कोई वीडियो फुटेज नहीं मिली है। लापता बच्चों के परिजनों की तहरीर पर थाना पुलिस ने गुमशुदगी का मामला दर्ज कर लिया है।

पुलिस परिजनों के साथ मिलकर

शुक्रवार रात से ही लगातार बच्चों की तलाश में जुटी है। लेकिन अब तक उनका कोई सुराग नहीं मिल सका है। प्रभारी निरीक्षक वर्मा ने बताया कि जंगल के सभी पोखरों और तालाबों की भी जांच कराई जा रही है। परिजनों ने उनके किसी तालाब में

नहाने के लिए उतरने और हादसा होने की आशंका जताई है। इसलिए पुलिस हर पहलू से लापता बच्चों का पता लगाने में जुटी है। पुलिस ने यह भी बताया कि नौंवी कक्षा में पढ़ने वाला हिमांशु यादव पहली बार गांव के दो बच्चों को साथ लेकर जंगल में घास काटने गया था।

शुक्रवार दोपहर घर से ट्यूशन पढ़ने की कहकर निकले बच्चे देर शाम तक नहीं लौटे तो परिजनों ने संभावित ठिकानों पर खोज करनी शरू की। तलाश में असफल परिजनों ने बच्चों की गुमशुदगी की रपट थाना मुरसान में दर्ज करवाई। देर रात तक पुलिस के प्रयासों से नाराज परिजनों ने रोड जाम करने का प्रयास किया लेकिन देर रात बच्चों के वृंदावन में होने की खबर पर परिजन शांत हो

थाना मुरसान के नगला खरगू निवासी आलोक शर्मा के दो पुत्र मनु (12) व यश (10) मन कक्षा पांच और यश कक्षा चार में पढ़ता है। शुक्रवार की दोपहर लगभग दो बजे अपने गांव नगला खरगू से रोज की तरह कस्बा मुरसान ट्यूशन पढ़ने की कहकर गए थे। बच्चे जब ट्यूशन पढ़ कर घर नहीं लौटे

तो परिजनों ने अध्यापक से संपर्क किया तो पता चला बच्चे ट्यशन पढने आए ही नहीं हैं। जब बच्चों की संभावित ठिकानों पर तलाश करने पर भी बच्चों का कछ पता नहीं चला तो परिजनों ने बच्चों का अपहरण हो जाने की आशंका जताते हुए मामले की शिकायत थाना मुरसान में दर्जे करा दी।

देर रात तक बच्चों का पता न चलने पर पुलिस पर लापरवाही बरतने का आरोप लगते हुए गांव वालों के साथ मार्ग जाम करने की बात कह कर थाना मुरसान के बाहर प्रदर्शन शुरू कर दिया।

बाद में बच्चों के वंदावन में होने की खबर मिलने पर परिजनों ने राहत की सांस ली। थाना मुरसान प्रभारी ने बताया कि संभवतः बुज क्षेत्र में रक्षाबंधन पर्व की छटा देखने की ललक बच्चों को वहां ले गई होगी। पुलिसकर्मी परिजनों को साथ ले रात में ही वुंदावन के लिए निकल गए।
