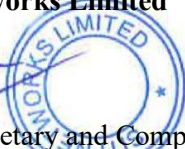

Had these expenses been disclosed on net basis, the 'Revenue from operations' and the 'Pay channel, carriage sharing and related costs' each would have been lower by ₹ 831.0 million, ₹ 844.1 million and ₹ 3,369.7 million respectively in the standalone financial results for the quarter ended 31 December 2021, quarter ended 31 March 2022 and year ended 31 March 2022 and ₹ 1,894.8 million, ₹ 1,805.9 million and ₹ 7,529.3 million respectively for the quarter ended 31 December 2021, quarter ended 31 March 2022 and year ended 31 March 2022 in the consolidated financial results. However, there would not have any impact on the net loss for the periods so mentioned.
