Opinion

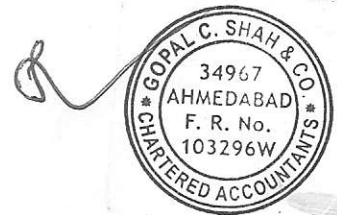
