### Sub: Scrutinizer's Report on remote E-voting and AGM Voting

I, Vishal R Thawani, proprietor of M/s. Vishal Thawani & Associates, Practicing Company Secretaries, Ahmedabad, appointed as a scrutinizer by the Board of directors of **Innovative Ideals and Services (India) Limited** ("the Company") pursuant to the applicable provisions of the Companies Act, 2013 read with rules framed thereunder for the purpose of scrutinizing the remote e-voting process and the voting through electronic voting system at the 20<sup>th</sup> Annual General Meeting of the Company in a fair and transparent manner for following resolution(s) as contained in the notice of 20<sup>th</sup> Annual General Meeting of the Company held on September 30, 2020, through video conferencing/ Other Audio Visual Means submit my report as under:
