JAIPUR: Bringing cheer to the parents amid Corona pandemic, the Rajasthan govt has directed the CBSE affiliated private schools to slash the tuition fees by 30% for class 9 to 12, while the schools affiliated with the state board have to reduce their fees by 40% for the

same classes. As the CBSE reduced the school syllabus from Class 9 to 12 by 30%, therefore their school tuition fees should be reduced by 30%. At the same time, the Rajasthan Board has reduced the syllabus by 40%, so they should reduce the fee by 40%, said the order.

NIA raids 6 NGOs, trusts in Delhi, J&K

Continuing the searches launched in Jammu and Kashmir on Wednesday, the **National Investigation Agency** (NIA) on Thursday further raided nine premises of six NGOs and trusts in Srinagar and Delhi on suspicion that these organisations were raising funds for charitable activities and then using them to carry out secessionist and separatist activities in the territory. NIA had registered a case on October 8 on the directions of the Ministry of Home Affairs on receipt of credible information that these NGOs and trusts collect funds domestically and abroad

through donations and business contributions in the name of various welfare activities such has public health and education and then the funds are sent to J&K through various channels such as hawala and cash couriers to sustain secessionist and terrorist activities. In a press note, it claimed several incriminating documents and electronic devices were seized during the searches. Offices of the Falah-e-Aam Trust, Charity Alliance, Human Welfare Foundation, J&K Yateem Foundation, Salvation Movement and J&K Voice of Victims (JKVoV) were being raided by the anti-terror probe agency sleuths.

The Jammu and Kashmir Police sealed the Srinagar office of People's Democratic Party (PDP) on Thursday and detained its workers protesting against the new land laws and ongoing NIA raids on six NGOs and trusts.

Taking to Twitter. Party chief Mehbooba Mufti said that the PDP won't tolerate attempts to change the Jammu and Kashmir demographics.

"The PDP office in Srinagar sealed by Jammu and Kashmir administration and workers arrested for organising a peaceful protest. A similar protest was allowed in Jammu so why was it thwarted here? Is this your definition of "normalcy", that's being showcased in the world," asked the former chief minister on Twitter. "PDP's Waheed

"Many others like Tahir Sayeed, Yasin Bhat, and Hameed Kohsheen also arrested. A government desperate to curb any kind of dissent and ready to crush its own people but all the machismo disappears when it comes to fighting China at the LAC (Line of Actual Control)," she said in another tweet.

Yeddy will be replaced after Bihar poll results: Congress

Even as BJP leaders are discussing the possibility of replacing BS Yediyurappa for favouring defectors who helped him form a government, the Congress says it has 'credible' information that the CM would be removed from his post after the Bihar elections. "I have accurate information

that Yediyurappa will not remain the chief minister after the Bihar elections," leader of opposition and former Chief Minister Siddaramaiah said. He was speaking to a local TV

channel. When pressed further, he said "I have accurate information from New Delhi that he won't remain the chief



minister after Bihar elections. I don't know if the BJP government will complete its term after Yediyurappa is made to resign. In case the government cannot continue, we are ready to fight elections," he said. Siddaramaiah's statement comes in the backdrop of BJP MLA from Bijapur, Basanagouda Patil Yatnal, saying that that Yediyurappa won't be the CM

for long and that a new candidate from North Karnataka would replace him. "Many MLAs are unhappy with Yediyurappa as funds have not been allocated for their constituencies," Siddaramaiah said. There is massive speculation in Bengaluru that Yediyurappa would be asked to step down from his post to make way for his successor. Several BJP leaders from North Karnataka who were unhappy about being sidelined had met at a hotel in Hubballi to discuss the potential candidate for Belagavi bye-polls on Wednesday. However, BJP sources said the leaders also discussed the issue of Yediyurappa's successor.

In the wake of the "Yuvraj of Jungle Raj" remark by Prime Minister Narendra Modi, Mahagathbandhan leader Tejashwi Yadav on Thursday said the PM of our country is free to say anything.

"We were expecting him to say something on unemployment, job creation, special package, starvation in Bihar but he has taken a different path to attack me. I don't want to comment on his remarks," Yadav said.

"The core issue of this election is unemployment, development and people know it. Despite this they [the NDA] are not talking on real is-

sues," he said further. Earlier, during the Madhubani rally on Wednesday evening, Yadav said the biggest enemies of the people of Bihar are unemployment and corruption. Bihar has a double-engine government and one of its engines created unemployment and the other was involved in corruption, he claimed.

Referring to Mithilanchal belt where Madhubani is located, he said: "This place has a huge scope of establishing agriculture-based industries. I want to ask the double-engine govt why there is no food processing unit here," Yadav had said.

DHARAVI: BACK TO TENDERS YET AGAIN After the committee of secretaries decided to scrap the tender process,

Seclink had said it would bid afresh.

The Dharavi Redevelopment Committee, a federation of 52 residents' associations, had opposed the earlier decision, saying it would further delay the project pending for 16 years. Under the proposed redevelopment, 67,000 families living in Dharavi were to get 350sqft houses. Housing Minister Jitendra Awhad, who had recently met Chief Minister Uddhay Thackeray with a plea for an early decision on Dharayi redevelopment, told The Free Press Journal, "The redevelopment will provide homes to the residents and will also bring in a churn in Mumbai's realty sector."

An official from the housing department said Seclink Technologies was the sole bidder and the previous government had extended the tender dates twice, to attract more bidders. In January 2019, the tender was opened. Seclink Technologies had placed a bid of Rs 7,200 crore against Adani Group's Rs 4,500 crore. The government was expected to issue the letter of award by February 7, 2019, but it did not take place. The official said the tendering process would commence after amendments to some terms and conditions, which would include the issue of transfer of 45 acres of railway land for the proposed redevelopment project.

PAK SPITS IN ITS OWN FACE

After a convoy of vehicles carrying Indian security personnel on the Jammu-Srinagar National Highway was blown away by a vehicle-borne suicide bomber on February 14 last year, Pakistan had condemned the attack and denied any connection to it. India had, of course, always blamed Pakistan for orchestrating the attack, the responsibility for which was claimed by the terrorist organisation Jaish-e-Mohammed (JeM). But Chaudhry has nailed his prime minister's lie that terror is not an instrument of State policy and that it was not in the country's interest to provide safe haven to terrorists. Khan also had the audacity to ask India for "proof" of Pakistani involvement.

Khan had then given the skewed reasoning that although Jaish is based in Pakistan, it also has a presence in Kashmir, and thus the attack is an "indigenous thing" that happened in India. "A Kashmiri boy was radicalised after the brutalities of the Indian security forces and he carried out the attack, but suddenly Pakistan came into the limelight," Khan had said. In the light of the confession by its Federal Minister, Pakistan cannot even keep up the pretence that the insurgency in Kashmir Valley is a 'home-spun' movement. The optics of it are likely to figure in global fora at a time Pakistan is desperately trying to keep itself off the FATF blacklist, which would lead to a multilateral fund squeeze. The comments are also a major embarrassment for some of the Opposition parties which had suggested by innuendo that the Pulwama strike was scripted by the Indian intelligence agencies.

It also comes less than two weeks after a schoolteacher, Samuel Paty, was beheaded north of Paris for showing cartoons of the Prophet to his class in a lesson on free speech.

Meanwhile, in Saudi Arabia, a man was arrested after stabbing a guard at the French consulate with 'a sharp tool'. The attacker was arrested while the guard was taken to hospital with non-life threatening injuries. France's embassy in Riyadh condemned the 'attack on diplomatic premises which can never be justified'.

Fine, we'll run trains but 1/3rd can travel

"Currently ticketing is being done through booking counters only, to restrict the issuance of tickets only to permissible categories of passengers. Once the suburban services are opened up for the public, tickets will have to be issued to all. For this, the UTS APP may have to be restarted, which we have disabled presently as it does not have the facility to only issue tickets to a particular category. Therefore, before opening up suburban services to the public, access to the station, through technological solutions will need to be ensured beforehand by the state government," an official said.

Moreover, the state government has suggested that a ladies special train be operated every hour but the railways fear that if this is done, women will gather at the platform, awaiting the ladies' special. "Similarly, the male passengers will also start accumulating to be able to board the train after ladies' special. Thus, the dwell time of both male and female passengers on the platforms will increase creating an artificial surge, a situation that we would like to avoid to maintain social

distancing," read the letter. Senior railway officials said the state government should quickly decide upon the technological solution they propose, to stagger the rush in the trains. It is learnt that the West Bengal government has already taken steps in this direction and the Maharashtra government is also considering the development of an app for the purpose.

"Meetings in this context have been held by the State Government on October 22 and 27, in which Central Railway and Western Railway officials also participated. Railways is willing to provide all statistical inputs to the sate government, if required, for development of this technological solution," said the official.

State lockdown till midnight of Nov 30

This means hotels, restaurants, food courts, gyms, salons, essential and non-essential shops, e-commerce services will continue to function. Besides, inter- and intra-district transportation, BEST will continue to operate at full capacity. However, schools and colleges will remain shut till further orders. The government's decision not to permit reopening of places of worship is significant in the face of the threat by some organisations to break open the locks and enter these places. Even more significant is the letter sent by Governor BS Koshyari to CM Thackeray on October 11, expressing serious displeasure and questioning the latter's Hindutva. This had prompted Thackeray to reply: "But I want to ask you whether reopening places of worship means

'Hindutva' and not reopening them means a person is 'secular'?" Munger SP, DM shunted

The outgoing SP had denied any police firing. Hours later, the Bihar government, on the instructions of the Election Commission, named 2010-batch IAS officer Rachna Patil as the new District Magistrate and 2009-batch IPS officer Manavjit Singh Dhillon as the new SP. The RJD-helmed Grand Alliance has strongly criticised Monday's firing, likening the action of the district police to that of General Dyer in Jallianwala Bagh.

Coming on the heels of the first phase of polling, the incident had its impact on voting too; two of the three Assembly seats – Munger and Jamalpur -- witnessed lower voter turnout, as against that in the 2015 polls. Lipi Singh, the Munger SP, is considered close to the chief minister. According to sources, she is treated like a member in the chief minister's household. She and her husband, an IAS officer, were in attendance during the annual puja for Nishant, Chief Minister Nitish Kumar's son. They were acting like his guardian during the proceedings, said sources.

for reporting such cases and that media trial hinders the administration of justice, which could amount to contempt of court. After considering the submissions, CJ Datta summoned Additional Solicitor General (ASG) Anil Singh and posed a series of queries to him, depicting various scenarios wherein excessive media coverage might

"Imagine there is excessive coverage; the accused in such a scenario might be on guard and end up either destroying the evidence or abscond. What if the media identifies a person to be a vital witness in the case. S/he could be won over, threatened or even physically harmed to ensure s/he doesn't testify," CJ Datta said.

The chief justice further said that in case the one who was being shown as the accused was actually innocent, "then this kind of excessive coverage might tarnish and damage that person's reputation," the court pointed out.

"Let us point out that such an impact is not only limited to an accused or an innocent person. What about the impact on the investigator," the CJ said, adding, "Take if the investigator is on a particular track, which is the right one. But then the media will say no, this isn't the correct track, then the investigator loses his track."

"And if a police officer doesn't get influenced by the media then it starts maligning him. Please elaborate if this is a welcome in a society governed by rule of law," CJ Datta remarked. Chief Justice Datta, accordingly, asked ASG Singh to address the court

on all these issues on the next date of hearing, which is on November 6. The judge further explained that usually the media defends itself in such cases, saying that it is part of their "investigative journalism". "But we think investigative journalism is just laying bare the truth," CJ Datta observed, adding, "We are unaware of any law that obliges an investigating officer to make public all the evidence in a case. "We fail to understand, how does the autopsy report come to the media unless the course of it is disclosed. Should we lay guidelines on these aspects?" CJ Datta asked Union government, while adjourning the case.
