PROCEEDINGS OF THE 14th ANNUAL GENERAL MEETING OF THE MEMBERS OF ASHAPURI GOLD ORNAMENT LIMITED HELD ON THURSDAY, THE 29TH DAY OF SEPTEMBER, 2022 AT 12:00 NOON

The 14th Annual General Meeting (AGM) of the Shareholders of ASHAPURI GOLD ORNAMENT LIMITED (AGOL) was held at 109 to 112A, 1st Floor, Super Mall, Nr. Lal Bunglow, C.G. Road, Ahmedabad-380 009, GJ,IN on Thursday the 29th day of September, 2022 at 12:00 Noon

The Chairman of the AGM Mr. Jitendrakumar Saremal Soni welcomed all Members, Directors, Auditors and other invitees to the 14th Annual General Meeting (AGM) of Ashapuri Gold Ornament Limited.

The Chairman confirmed that the quorum was present and declared the meeting in order and open for business.
