The Stakeholders Relationship Committee (SRC) of Board of Directors of the Company has *vide* Circular Resolution dated May 22, 2024 approved the allotment of 39,427 Equity Shares of Rs.5/- each on May 24, 2024 at 04:10 AM (IST) to the option grantees who have exercised their options granted under the ESOP Schemes detailed hereunder:

- 14,240 Equity Shares under the Intellect Stock Option Plan 2015 (ISOP 2015) Scheme
