Subject: Summary of the proceedings of the 80th Annual General Meeting

The 80th Annual General Meeting ("AGM") of the Members of the Company was held today i.e. Thursday, July 29, 2021 at 3.30 p.m. through Video Conferencing ("VC") / Other Audio Video Means ("OAVM").
