This is in continuation to our letter dated 03.09.2021 regarding "Outcome of Board meeting", we wish to inform you that the 35th Annual General Meeting (AGM) is scheduled to be held on Thursday, **September 30**, **2021** at the registered office of the Company i.e. at Village Somalheri/Lehli, P.O Dappar, Tehsil Derabassi, Distt. Mohali, Puniab.

In compliance with the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time and Regulation 44 of the Securities and Exchange Board of India (SEBI) (Listing Obligations and Disclosure Requirements), Regulations 2015, the Company will provide remote E-voting Facility to its members as an alternate mode to exercise their right to vote by electronic means for transacting the business at the 35th AGM of the Company.
