मुंबई, दि. १४ (हिंदुस्थान समाचार) : राज्यातील छोट्या आणि मध्यम वृत्तपत्रात प्रसिद्ध झालेल्या सरकारी जाहिरातीची कोट्यवधीची थकबाकी सरकारकडून घेणे बाकी आहे. ही रक्कम सरकारने त्वरित चुकती करावी, अशी मागणी मराठी परिषदेचे मुख्य विश्वस्त एस.एम.देशमुख यांनी मुख्यमंत्री उद्धव ठाकरे यांना पाठविलेल्या पत्रात केली आहे.

कोरोना आणि लॉकडाऊनमुळे राज्यातील वृत्तपत्र व्यवसाय मोडकळीस आलेला आहे. सर्वच वृत्तपत्रे आर्थिक अडचणीत सापडली असल्याने त्यांच्या समोर अस्तित्वाचा प्रश्न निर्माण झाला आहे. सरकार वृत्तपत्रे आणि पत्रकारांसाठी कोणताच दिलासा देताना दिसत नाहीत. उलट वृत्तपत्रातून प्रसिद्ध झालेल्या जाहिरातीची बिलं देखील दिलं जात नसल्याने संकट अधिकच उग्र झाले आहे. युतीच्या काळात विद्यमान अर्थमंत्री अजित पवार यांनी वृत्तपत्रांची बिलं त्वरित घावीत अशी मागणी विधान सभेत केली होती. म्हणजे त्यांना विषयाचे गांभीर्य माहितही आहे.
