

श्रीलंकेने मागितले भारताकडे कर्ज

कोलंबो, ता. २४: श्रीलंकेला परकी चलन टंचाईचा सामना करावा लागत असताना आज मंत्रिमंडळाने पेट्रोलियम उत्पादनाच्या खरेदीसाठी भारतीय एक्झिम बँकेकडे ५० कोटी अमेरिकी डॉलरचे कर्ज मागण्याच्या प्रस्तावाला मंजुरी दिली. पेट्रोल पंपावरच्या रांगा कमी करण्यासाठी श्रीलंका सरकारकडून युद्धपातळीवर प्रयत्न केले जात आहेत. परकी चलनाची टंचाई जाणवत असल्याने आयातीचे बिल भरण्यास श्रीलंकेला अडचणी येत आहेत. ऊर्जामंत्री कंनचा विजेसेकरा यांनी सांगितले की, कालच्या मंत्रिमंडळ बैठकीत भारतीय एक्झिम बँकेकडून ५० कोटी डॉलरचे कर्ज घेण्यास मंजुरी देण्यात आली.
