Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in furtherance to intimation made on November 1, 2018, we hereby intimate that Environment Pollution (Prevention & Control) Authority ("EPCA") for the National Capital Region ("NCR") issued directions dated November 10, 2018 in furtherance to earlier notice dated October 27, 2018, pertaining to the rising pollution levels in NCR. The said directions inter-alia provide that '*Ban on industries using coal and biomass, including brick kilns. This ban does not include power plants and waste to energy plants*' till November 12, 2018. A copy of the said directions is attached for easy reference.

Therefore, in compliance with the aforementioned directions issued by EPCA, the Company has shut down its Ballabgarh plant situated at Faridabad, Haryana till today i.e. November 12, 2018.

This is further to letter of October 27, 2018, October 31, 2018 and November 6, 2018 on the implementation of the Graded Response Action Plan (GRAP) and the measures to be taken to control air pollution. All the measures that were directed were to come to an end on November 10, 2018.


The CPCB headed Task Force has informed EPCA late night on November 9th that given the prevailing adverse conditions the following measures will remain closed until November 12, 2018, when it will further review the situation and inform us accordingly:

The measures that will remain banned till November 12, 2018 are as follows:

1. Ban on industries using coal and biomass, including brick kilns. This ban does not include power plants and waste to energy plants.
2. Ban on entry of truck traffic to Delhi (except essential commodity)
3. Ban on construction activities

You are requested to immediately take steps to ensure compliance of these directions.
