The listing approval from the Stock Exchange has also received to the Company from BSE on November 09, 2022 and from NSE on November 09, 2022

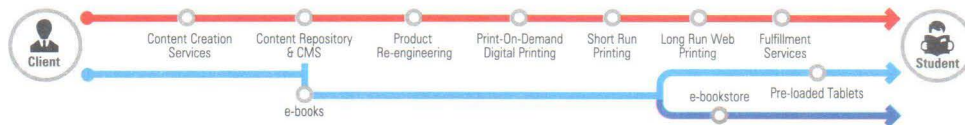

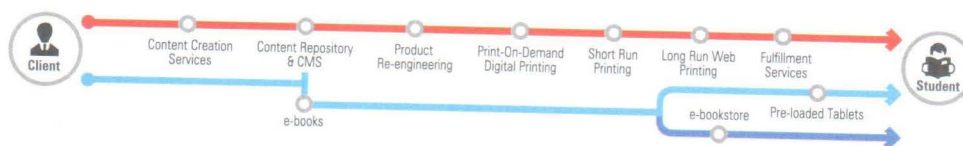
