In view of the extension provided to the Corporates in providing both voting by physical ballot and e-Voting, a facility was extended for the members to cast their votes only through e-Voting in accordance with the provisions of the MCA Circulars.

The Management of the Company is responsible to ensure the Compliance of the requirements of the Actand the Rules framed thereunder as also under the Listing Regulationsrelating to voting through e-Voting process and for the Resolution(s) proposed in the Notice of Postal Ballot of the Company dated October 20,2023.



My responsibility as a Scrutinizer is restricted to making Scrutinizer's Report of the votes cast by the members in respect of the resolutions contained in the Notice. My Report is based on the Report generated from e-Voting system provided by the National Securities Depository Limited (NSDL), the agency engaged by the Company to provide e-Voting facilities for voting through electronic means in respect of the resolutions as contained in the Postal Ballot Notice.

As per the information furnished to me by the Company and after carrying out the scrutiny of the Postal Ballot (e-Voting) received from the Members of the Company, I submit my report as under:

The Company on Friday, December 15,2023has completed sending of Postal Ballot Noticeand Explanatory Statement to its Members by e-Mail whose name(s) appeared on the Register of Members/List of Beneficial Owners maintained by the Company/ Depositoriesas on ,Thursday, December 14, 2023 ("Cut-off date") and whose e-Mail IDs are registered with the Company/Depositories...
- 3. In terms of the aforesaid Postal Ballot Notice and as prescribed in the aforesaid rules, the e-Voting facility was kept open for thirty (30) days period commencing on Saturday, December 16, 2023 at 09:00 A.M. IST and ended on 05:00 P. M. IST on Sunday, January 14, 2024 and Members were requested to cast their votes electronically conveying their assent or dissent in respect of the resolutions on e-Voting platform provided by NSDL.
- 4. The Members of the Company holding shares as on "Cut-off Date" i.e Thursday, December 14, 2023 were entitled to vote on the Resolutions proposed in the Notice of Postal Ballot of the Members of the Company dated October 20, 2023.
- 5. The requisite Public Advertisement with respect to dispatch of Postal Ballot Notice pursuant to Section 108 of the Companies Act, 2013 read with Rule 20(4)(v) of the Companies (Management and Administration) Rules, 2014 (as amended) was published in the daily Newspaper viz. "The Financial Express" (in English language) and "Loksatta" (in Marathi language) on Saturday, December 16, 2023.
- 6. Particulars of all the votes cast by electronic means have been entered in a register separately maintained for the purpose.

Further, the Board of Directors had appointed Mr. Girish Bhatia, Practicing Company Secretary (FCS 3295 CP No. 13792), as scrutinizer to conduct the Postal Ballot through e-voting process in a fair and transparent manner.

The Company had engaged the services of National Securities and Depository Limited ('E-voting Agency/NSDL') for providing e-voting facility to all the Members of the Company on the cut-off date, in terms of the provisions of Sections 110, 108 and other applicable provisions of the Act, MCA Circulars, and SEBI Listing Regulations.
