I, P. S. Bathla, Practicing Company Secretary, having office at SCO-6, Feroze Gandhi Market, Ludhiana-141001 was appointed as the Scrutinizer of KIOCL LIMITED ("the Company") for the purpose of scrutinizing the conduct of remote e-voting process as well as e-voting at the 47th AGM in a fair and transparent manner pursuant to the provisions of Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, MCA circular dated December 28, 2022 and SEBI circular dated January 5, 2023 and ascertaining the requisite majority on the resolutions transacted at the 47th Annual General Meeting (AGM) of the Equity Shareholders of the Company.

My responsibility as a Scrutinizer is to ensure that the voting process, both through remote e-voting and e-voting at the 47th AGM, are conducted in a fair and transparent manner and to render consolidated scrutinizer's Report of the total votes cast "in favour" or against", if any, to the Chairman on the resolutions, based on the reports generated from the electronic voting system provided by Central Depository Services (India) Limited (CDSL) at the 47th AGM.

I submit herewith my Consolidated Scrutinizer's Report as under:

- 1. In view of compliance with the aforesaid MCA circular and SEBI Circular, the Annual Report along with Notice of 47th AGM dated 9th August, 2023 was sent to the shareholders in respect of the resolutions mentioned in the aforesaid AGM Notice through electronic mode on August 29, 2023, whose email addresses are registered with the Company/Depositories.
- 2. The Company has availed services of Central Depository Services (India) Limited ("CDSL") for providing e-voting facility for conducting remote e-voting and e-voting during the Annual General Meeting, to the shareholders of the Company, the remote e-voting remained opened from 19th September, 2023 (9.00 AM) to 21st September, 2023 (5.00 PM).
- 3. The Members holding shares as on the "cut off" date i.e., 15th September, 2023 were entitled to vote on the proposed resolutions (Item No. 1 to 8 as set out in the Notice of 47th AGM of the Company).
- 4. At the 47th AGM held through Video Conferencing (VC) or other Audio-Visual Means (OAVM), e-voting facility was provided to those members who have not cast their vote through remote e-voting and are otherwise not barred from doing so, to enable them to exercise their voting rights on the Resolutions as contained in the 47th AGM Notice. Members who have voted through remote e-voting prior to the 47th AGM were not eligible to vote again during the meeting. Further, pursuant to MCA Circular No. 14/2020 dated April 8, 2020, the facility to appoint a proxy to attend and cast vote for the members was not made available for the 47th AGM. However, President of India/Governors of State & Body Corporates were entitled to appoint authorized representatives to attend the 47th AGM through VC/OAVM and participate thereat and cast their votes through e-voting.
- 5. The votes cast through remote e-voting as well as e-voting held at the meeting were unblocked on 22nd September, 2023 at 01:22 PM in the presence of two witnesses namely Mr. Gurmail Singh & Ms. Rekha Rani residing at Ludhiana who are not in the employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.
