Pursuant to Circulars dated January 13, 2021 read with together Circular dated 8th April, 2020 followed by Circular dated 5th May, 2020 of the Ministry of Corporate Affairs (MCA) and Securities Exchange Board of India (SEBI) Circular dated 12th May, 2020 read with Circular dated 15th January, 2021, 50th Annual General Meeting (AGM) of the Company will be held on Tuesday, the 28th September, 2021 at 4:00 P.M through Video Conferencing/ Other Audio Visual Means ("VC/OA VM") only without the physical presence of the members at the venue. Pursuant to Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Register of Members and Share Transfer Books of the Company will remain closed from **Wednesday, 22nd September, 2021 to Tuesday, 28th September, 2021 (both days inclusive)** for the purpose of Annual General Meeting.

The Company has fixed **Tuesday, 21st September, 2021** as the "**CUT-OFF DATE**" for determining the eligibility of the members to vote by remote e-voting or e-voting at the Annual General Meeting.


The Company would be availing remote e-voting services of National Securities Depository Limited (NSDL) prior to and during the AGM. The remote e-voting period commences on **Friday, 24th September, 2021 (9.00 A.M)** and end on **Monday, 27th September, 2021 (5.00 P.M)**.
