पश्चिम मध्य रेलवे के मुख्य जनसंपर्क अधिकारी राहुल श्रीवास्तव ने बताया कि रानी कमलापति-हजूरत निजामुद्दीन वंदे भारत एक्सप्रेस ट्रेन

सुबह पांच बजेकर 40 मिनट पर भोपाल से रवाना हुई।

उन्होंने एक बयान में कहा, जब यह कलहार स्टेशन से गुजर रही थी तो स्टेशन प्रबंधक ने सी-14 बोगी को बैटरी बॉक्स से धुआं निकलते देखा, जिसके बाद उन्होंने वरिष्ठ अधिकारियों को सूचना दी और ट्रेन को कुरुवाई-कैथोरा स्टेशन पर रोक दिया गया। उन्होंने बताया कि दमकल कर्मियों ने सुबह करीब आठ बजे आग पर काबू पाया।

अधिकारी ने कहा कि बैटरी बॉक्स बोगी के नीचे यात्रियों की सीटों से काफी दूरी पर होता है। बैटरी बॉक्स में आग लगते ही विद्युत सुरक्षा प्रणाली ने बैटरियों को उससे अलग कर दिया। उन्होंने बताया कि बैटरियां हटा दी गईं और आग बुझा दी गई है। अधिकारियों ने बताया कि रेलवे

कर्मचारियों द्वारा मरम्मत कार्य करने के बाद ट्रेन ने सुबह करीब सवा 10 बजे अपनी आगे की यात्रा फिर से शुरू की। ग्वालियर जाने के लिए इस ट्रेन में यात्रा कर रहे वरिष्ठ कांग्रेस नेता और मध्य प्रदेश विधानसभा में विपक्ष के पूर्व नेता अजय सिंह ने कहा कि आग का पता चलते ही ट्रेन रोक दी गयी।

सिंह ने पीटीआई-भाषा से फोन पर कहा, लोग यह देखने के लिए नीचे उतर गए कि क्या हुआ। सभी यात्री सुरक्षित हैं। लगभग साढ़े तीन घंटे तक रुकने के बाद ट्रेन वहां से रवाना हुई। इस साल एक अप्रैल को प्रधानमंत्री नरेंद्र मोदी ने यहां रानी कमलापति स्टेशन से हजरत निजामुद्दीन के बीच वंदे भारत ट्रेन को हरी झंडी दिखाई थी। यह ट्रेन शनिवार को छोड़कर सप्ताह में छह दिन चलती है।

सोमवार को सुबह आठ बजे जारी अद्यतन आंकड़ों के मुताबिक, देश में कोरोना वायरस संक्रमण से अभी तक 5,31,915 लोगों की मौत हुई है। आंकड़ों के अनुसार, भारत में अभी तक 4.49 करोड़ से अधिक लोग कोविड-19 से संक्रमित हो चुके हैं, जबकि मरीजों के ठीक होने की राष्ट्रीय दर

98.81 प्रतिशत है। आंकड़ों के मुताबिक, देश में कुल 4,44,61,565 लोग इस संक्रमण को मात दे चुके हैं, जबकि कोविड-19 से मृत्यु दर 1.18 फीसदी दर्ज की गई है।

स्वास्थ्य मंत्रालय की वेबसाइट के अनुसार, भारत में राष्ट्रीय टीकाकरण अभियान के तहत अभी तक कोविड-19 रोधी टीकों

की 220,67,47,763 खुराक दी जा चुकी है।

गौरतलब है कि भारत में सात अगस्त 2020 को कोरोना वायरस संक्रमितों की संख्या 20 लाख, 23 अगस्त 2020 को 30 लाख और पांच सितंबर 2020 को 40 लाख से अधिक हो गई थी। संक्रमण के कुल मामले 16 सितंबर 2020 को 50 लाख, 28 सितंबर 2020 को

60 लाख, 11 अक्टूबर 2020 को 70 लाख, 29 अक्टूबर 2020 को 80 लाख और 20 नवंबर को 90 लाख के पार चले गए थे।

देश में 19 दिसंबर 2020 को ये मामले एक करोड़ से अधिक हो गए थे। चार मई 2021 को संक्रमितों की संख्या दो करोड़ और 23 जून 2021 को तीन करोड़ के पार पहुंच गई थी।
