At your request, Noticee No.1 CHALLA SRINIVASA RAO has been granted by Manappuram Home Finance Ltd or "Bank", through its VIJAYAWADA Branch, credit facility by way of financial assistance ("Financial Assets") against an asset in which security interest was created in favour of the Bank. The relevant particulars of the said credit facility and the security agreement(s) document(s) executed by you Noticees are stated in Schedule 'A' and 'B' respectively. You have availed the said financial assistance inter alia with an undertaking for repayment of the said financial assistance in terms of the corresponding agreement(s) document(s).

You Noticee No.1, along with Guarantors & Mortgagors have also created security interest by way of deposit of title deeds with respect to, the immovable properties detailed under Schedule 'C', creating security interest thereon in favour of the Bank.

Your outstanding liabilities (in aggregate) due and owing to EARC is in the sum of Rs. 13,35,438.28/- (Rupees Thirteen Lakhs Thirty-Five Thousand Four Hundred Thirty-Eight and Twenty-Eight Only) as on 02-11-2024 You are also liable to pay future interest at the contractual rate on the aforesaid amount together with incidental expenses, cost and charges from 03-11-2024.

If you fail to repay to EARC the aforesaid sum of Rs. 13,35,438.28/- (Rupees Thirteen Lakhs Thirty-Five Thousand Four Hundred Thirty-Eight and Twenty-Eight Only) as on 02-11-2024 with further interest and incidental expenses, costs and charges as stated above in terms of this notice u/s 13 (2) of the Act within 60 days of this notice, EARC will exercise all or any of the rights detailed under sub-section 4 of Section 13 and other applicable provisions of the said Act.

You are also put to notice that in terms of sub-section 13 of section 13, you are hereby legally disallowed from transferring by way of sale, lease or otherwise, the secured assets detailed in Schedule 'C' of this notice.

Your attention is also invited to the provision of sub-section 8 of section 13 of the Act in respect of the time available to you Noticees to redeem the underlying secured assets.
