# Ayodhya Guptar Ghat

## Where Lord Rama meditated for last time

River, that legend states Lord Rama engaged in his final meditation before embracing Jal Samadhi—a spiritual ritual of merging with water. This profound act marked his departure from the mortal world and his ascent to the celestial realm of Vaikuntha, as an incarnation of the supreme Lord Vishnu. Even as centuries pass, the sanctity of Guptar Ghat endures, a testament to Lord Rama's transcendence.

While the ghat's proper name is Gopraatar Ghat, it is commonly known as Guptar Ghat in popular discourse. This revered site lies on the banks of the holy Sarayu River in Ayodhya, and it is steeped in history, legend, and spirituality. **Architecture**

Guptar Ghat is a striking complex of stone and brick steps that descend into the river, leading devotees to the waters of the Sarayu. The ghats are beautifully adorned with intricate pillars and arches, enhancing the serene ambience. Several temples and shrines can be found at the ghat, including the Sita-Ram Temple, the Chakrahari Shrine, and the Narasingh Temple, each dedicated to the divine deities worshipped by countless followers.

### Legends of Lord Rama's departure

The legend of Lord Rama's Jal Samadhi at Guptar Ghat is rooted in ancient scriptures, particularly the Valmiki Ramayana. After his victorious



Rama, aware of his fate, instructed his brother Lakshman to ensure that no one entered the room while he and Yama conversed. But then, the fiery sage Durvasa appeared. Known for his quick temper, Durvasa threatened to curse Lord Rama. Lakshman, in his devotion, sought to protect his brother and decided to sacrifice himself to prevent the curse. Without hesitation, he entered the room and offered himself in Rama's stead. Stricken with grief but unwilling to harm his brother, Lord Rama exiled Lakshman.

Lakshman, heartbroken, disappeared into the Sarayu River, where it is believed he merged with the divine serpent Sheshnag. In the same spirit, Lord Rama chose to take Jal Samadhi at the banks of the river, leaving his earthly body behind to return to his divine form.

The Ramayana describes how, at the appointed time, Lord Rama, surrounded by his devotees and the 33 celestial deities who had joined him on Earth, removed his sandals and entered the waters of the Sarayu River. This marked the end of his earthly incarnation, and he ascended to Vaikuntha, his eternal home.


battle against Ravana, Lord Rama returned to Ayodhya, where he ruled for 11,000 years. As his earthly existence drew to a close, it was at Guptar Ghat that he chose to leave the world.

According to myth, after the earth swallowed his beloved consort, Sita, Lord Rama knew his work on earth was complete. He had already dispatched his loyal companion Hanuman to the netherworld to retrieve a ring, understanding that Hanuman would be unable to relinquish his human form if he stayed on Earth. Soon after, the god of death, Yama, disguised as a sage, arrived to inform Lord Rama that it was time for him to return to Vaikuntha.

Guptar Ghat, nestled in the heart of Ayodhya, is one of the crown jewels of this sacred city. Located about 9 kilometers from the revered Hanuman Garhi, Guptar Ghat attracts thousands of devotees every year. Pilgrims from all over the world visit this holy site to connect with the divine legacy of Lord Rama.

It is at Guptar Ghat, beside the peaceful currents of the Ghaghara
