Sub: Further development in the Tenders of CFM Mozambique

Dear Sir/Madam,

This is pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular no. CIR/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 and in furtherance to our letter No. RITES/SECY/NSE dated **July 24, 2023** regarding RITES emerging as lowest bidder in two (2) tenders from CFM Mozambique subject to award after due process of CFM Mozambique's scrutiny / evaluation. Out of the two tenders, one was for supply of 10 Diesel Electric Locomotives with incidental service and the other was for supply of 300 High side Wagons.

CFM Mozambique after due process of scrutiny / evaluation has conveyed the following developments in the tenders vide their letter dated 13th November 2023 :

1. All bidders have been advised that the tender for 10 Diesel Electric Locomotives with incidental services has been awarded to RITES at a total value of USD 37,680,080 (Thirty Seven Million Six Hundred Eighty Thousand and Eighty US Dollars). The bidders have also been given opportunity to contest the decision within 3 working days from the date of the letter. The said period expired on 16th November 2023.
2. All bidders have been advised that the tender for 300 High Side Wagons has been awarded to bidder other than RITES.
