With reference to the captioned subject, we wish to inform you that Board of Directors of the Company in their meeting held on 23rd February, 2021, has accorded consent for reduction in remuneration of Mr. Mukund Narayan Kulkarni, Chairman & Managing Director of the Company from Rs. 4,50,000/- per month to Rs. 1,80,000/- per month and Mr. Suresh Gunwant Fegde, Whole-Time Director of the Company, from Rs. 4,50,000/- per month to Rs. 1,80,000/per month considering the impact of COVID 19 which Company faced with regard to problem in working capital requirement and liquidity and as a financial measure to control over fixed financial expenses and cash outflow the remuneration was reduced.

The revised remuneration is within limit of Rs 7,00,000/- (Rupees Seven Lakhs) per month i.e. overall limit of Rs 84,00,000/- p.a. as approved by the Shareholders of the Company in their Extra Ordinary General Meeting held on 21st December, 2019.
