দুরন্ত বার্তা, হিলি, ৮ সেপ্টেম্বর ঃ দক্ষিণ দিনাজপুরে শেষমুহুর্তে নাবালিকার বিয়ে রাখল পুলিশ-প্রশাসন। বাড়িতে জোরকদমে প্রস্তুতি চলছে। এমন সময় অভিযান চালিয়ে লুকিয়ে রাখা পাত্রীকে উদ্ধার করে বিয়ে ভভুল করল প্রশাসন। বৃহস্পতিবার সকালে হিলি থানার বিনশিরা পঞ্চায়েতের শ্যামপুর এলাকার ঘটনা। বিয়ের আসর থেকে সটান উধাও হয়ে গেল হবু বর। তড়িঘড়ি পাত্রীকে নিরাপদ আশ্রয়ে আড়াল করল পাত্রপক্ষের লোকেরা। তবুও শেষ রক্ষা হল না। তল্লাশিতে উদ্ধার নাবালিকা। হিলি থানার বিনশিরা পঞ্চায়েতের শ্যামপুর এলাকার ঘটনা। সেখানে নাবালিকার বিয়ের আয়োজন চলছে এমন খবর গোপন সূত্র মারফত জানতে পারে ব্লক প্রশাসন। খবরের ভিত্তিতে অভিযান চালানো হয়। হিলি ঝুকের মাস এড়ুকেশন আধিকারিক শ্রীমন্ত দলুই, হিলি থানার সাব ইনস্পেকটর মুকুল মহন্ত, স্যাগ কেপির কো-অর্ডিনেটর নীহার পাল, পিএলভি অপিতা দাস, উজ্জীবন সোসাইটির সদস্যরা অভিযানে উপস্থিত ছিলেন। হিলির ১৭ বছরের নাবালকের সঙ্গে বালুরঘাট থানার রাধানগর গ্রামের ১৫ বছরের নাবালিকার বিয়ে ঠিক হয়েছিল। শ্যামপুরে পাত্রের বাড়িতে ওই বিয়ে অনষ্ঠিত হওয়ার কথা ছিল। কিন্তু এদিন সকালে প্রশাসন অভিযান চালাতেই বাড়িতে তালা ঝুলিয়ে পাত্র ও তার পরিবার উধাও হয়ে যায়। এরপর ওই এলাকায় তল্লাশি চালিয়ে প্রতিবেশীর বাড়ি থেকে পাত্রী সহ পাত্রের পরিবারকে উদ্ধার করে প্রশাসন। তারপরই প্রাথমিক আইনি প্রক্রিয়া শেষে নাবালিকাকে চাইল্ড ওয়েলফেয়ার কমিটিতে পাঠানোর প্রক্রিয়া শুরু

ব্যবসায়ীদের ক্ষোভ

দুরন্ত বার্তা, ইটাহার, ৮ সেপ্টেম্বর ঃ দুষ্কৃতীদের গ্রেফতারির দাবি জানিয়ে ব্যবসায়ী সমিতির পক্ষ থেকে ব্যবসা বন্ধ করে বিক্ষোভ। ঘটনাটি ঘটেছে উত্তর দিনাজপুর জেলার ইটাহারের দুর্গাপুরে বাজারে। ব্যবসায়ীরা জানাচ্ছেন বহিরাগত কিছু দুষ্কৃতী গাড়ি রাখাকে কেন্দ্র করে এক ব্যবসায়ীর উপর আক্রমণ করে এবং একদিন পরে এসে ওই ব্যবসায়ীকে না পেয়ে তার দোকানের কর্মচারী ও নাবালক বাচ্চাকে মারধর করে। তাই ব্যবসায়ীরা ব্যবসায়ী সমিতির পক্ষ থেকে ইটাহার থানায় লিখিত অভিযোগ দায়ের করেন। কিন্তু পুলিশ কাউকে গ্রেফতার না করায় ব্যবসায়ীরা সমস্ত বাজার বন্ধ করে বিক্ষোভ দেখান। তাদের দাবি অবিলম্বে ওই দুষ্কৃতীকে গ্রেফতার করতে হবে, না হলে তারা বৃহত্তর আন্দোলনে নামবেন।

আমবাগানে সিভিক ভলান্টিয়ারের ঝুলন্ত মৃতদেহ উদ্ধার ঘিরে চাঞ্চল্য

দুরন্ত বার্তা, চাঁচল, ৮ সেপ্টেম্বর ঃ মালদার চাঁচল থানার গোপালপুরে আমবাগান থেকে উদ্ধার এক সিভিক ভলান্টিয়ারের ঝুলন্ত দেহ। বৃহস্পতিবার সকালে ঘটনাকে ঘিরে চাঞ্চল্য ছড়িয়েছে এলাকায়। জানা গিয়েছে, মৃতের নাম মনজির উরঙ্গজেব (৩৪)। তিনি চাঁচল থানায় সিভিক ভলান্টিয়ার হিসেবে কর্মরত ছিলেন। এদিন খবর পেয়ে পুলিশ ঘটনাস্থলে গিয়ে আমবাগান থেকে ঝুলন্ত দেহটি উদ্ধার করে। পরবর্তীতে দেহ ময়নাতদন্তের জন্য মালদা মেডিকেল কলেজ ও হাসপাতালে পাঠানো হয়েছে। খুন না আত্মহত্যা তা তদন্ত শুক করেছে পুলিশ। পুলিশ ও স্থানীয় সূত্রে জানা গিয়েছে, এদিন সকালে গ্রামের চাষিরা কাজে যাওয়ার সময় আমবাগানে মনজিরের ঝুলন্ত দেহ দেখতে পান। তারপরই পুলিশে খবর দেওয়া হয়। মৃত সিভিকের বাড়িতে রয়েছে স্ত্রী, দুই সন্তান ও বাবা-মা। মৃতের পরিবার সূত্রে জানা গিয়েছে, বুধবার সন্ধ্যায় চাঁচল থানার সিভিক ভলান্টিয়ার ফিরদৌসি খাতুন দলবল নিয়ে মনজিরের বাড়িতে চডাও হয়। সেইসময় মনজির বাডিতে ছিলেন না। তখন তাঁর স্ত্রী ও মাকে হুমকি দেন ফির্নৌসি খাতন। সে জানায়, মনজির আমার ফোন রিসিভ করছে না। এমনকি প্রাণনাশের হুমকিও দেয় সে। তারপরেই রাত থেকে নিখোঁজ ছিল মনজির। বাড়ির সদস্যরা তল্লাশিও চালাচ্ছিল। তবে সকাল হতেই তাঁর ঝুলন্ত দেহ উদ্ধার হয়। পরিবারের দাবি, ফিরদৌসি খাতুনই খুন করেছে মনজিরকে।
