Devotees brave cold weather to take holy dip in Triveni-Sangam



PRAYAGRAJ : Despite the intense cold and the coronavirus pandemic, approximately 30 lakh devotees bathed in the icy waters of the Ganga river and at Triveni-Sangam in Prayagraj until 6 p.m.

On the auspicious occasion of Basant Panchami, the fourth major bathing festival of the ongoing Magh Mela, devotees began thronging the river banks in the early hours of the day, according to officials, and many more are expected to come for

a holy dip till late night. According to an official, eight new lost and found certificates have been established in the fair area due to the large number of devotees who came for a holy dip on Basant Panchami.

The pleasant weather later in the day, as well as the proper arrangements made by mela authorities, added to devotees' festive spirit.

Under the watchful eye of the Jal police, devotees took holy dips at mela ghats. The ghats, which

were barricaded for pilgrim safety, saw a large influx of devotees beginning early in the morning. Many devotees remained at the ghats until late in the evening. Before dawn on Saturday, the majority of devotees, mostly from rural areas, began arriving at the ghats barefoot and dressed in traditional attire. Small children dressed as Lord Shiva, Parvati, and Janki drew a crowd. On the occasion, a group of devotees also organized bhandara.

"We had planned to come

on the occasion of Mauni Amavasya, but due to the extreme cold on the day, we had to cancel our visit. However, the weather was pleasant on Saturday, so we decided to come and seek the Ganga's blessings on this auspicious day "Shalini, a devotee from Kaushambi, spoke up.

Devotees were seen offering water to the Sun God and performing aarti. The Magh Mela began on January 14th, in the midst of the latest wave of the coronavirus pandemic, which is being driven by its Omicron variant. Coronavirus norms, such as wearing face masks and maintaining social distance, are frequently thrown to the wind at such large gatherings.

marks was found. According to police, kin claimed that the man was killed because of an old dispute. Sheetala Prasad, 50, was a resident of Dhumnaganj's Neewa area who used to catch and sell fish for a living, according to reports. Sheetala went fishing in Ganga on Friday but did not return home.
