Vistaar Capital told to wind up film fund in six months

FE BUREAU Mumbai, April 24

THE SECURITIES AND Exchange Board of India has directed Vistaar Capital Advisors (VCAL), its trustee and directors to wind up Vistaar Religare Media Fund, aventure capital fund that funded films, capital fund that funded films by providing exit to unitholders within six months, and barred VCA from accessing the capital market.

The order follows an inspection of the tund between 2008 and July 2017.

VCAL is the investment manager to the fund, while Vistra ITCL (India) is the

trustee of the fund.

The fund, which was launched in 2008 and raised launched in 2008 and raised funds to the tune of ₹43 crore, was supposed to close in 2013 as no extension was granted The fund made 52.72% of its total investments in five SPVs, in violation of VCF Regula

in violation of VCF Regula-tions, which provide that not more than 33.33% of investible funds of a fund can be invested in SPVs.

The fund did not maintain the records of complaints received by it and did not take any step to reply to the com-plainants or redress the same. There was absence of records with respect to details of invest-

ments and exits by the tund.
Two separate valuations of all the assets of the scheme of the fund will be obtained from two registered valuers. The NAV of the scheme will be determined on the basis of the higher of the two valuations or 44 million, whichever is the control of ₹4 million, whichever is higher.
