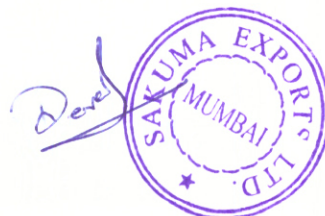
Sub: Relaxation for submission of Quarterly Results for Quarter and Year ended March 31st, 2020

Sakuma Exports Limited (having CIN: L51909MH2005PLC155765) (“the Company”) is a Company having its registered office at A-301, Aurus Chamber, S S Amrutwar Lane. Nr. Mahindra Tower, Worli, Mumbai – 400013.

The Company has listed its security on Bombay Stock Exchange Limited (“**BSE**”) as well as National Stock exchange of India Limited (“**NSE**”).

As per the statutory requirements of SEBI (Listing Obligation and Disclosure Requirement), Regulations, 2015 (“**Listing Regulations/ LODR**”). Every listed entity is required to publish their quarterly results within 45 days of the closure of the quarter and 60 days from the end of the 31st March. After extension the last date of submission of quarterly result is 30th June, 2020. Considering the current situation of Covid-19 pandemic and resultant lockdown, our all the office premises has been closed down. As government has



granted some relaxation for reopening of business in lockdown but still in some of the containment zones there has been no relaxation given as of now. Company's registered office is also situated in one of such containment zone which is Worli., Mumbai. Accordingly, Company is not allowed to operate its registered office and as a result of that it becomes hinderance to Company to perform its day to day operations.

For efficient and effective compliance of the submission of the quarterly results of the Company for the March 31, 2020 office bearers need to go to the office. But as Company's office is in containment zone it is not feasible for the Company officials to go to the office and work from there.

We hope these submissions would enable you to understand the factual position with respect to the submission of the quarterly results of the Company for the quarter and financial year ended March 31st, 2020 and in view of the circumstances as narrated above, **we request you to grant us some sufficient time at least of 30 days for submit the quarterly results and take a lenient view of the matter.**
