एए के खिलाफ प्रदर्शन कर रहे लोगों के बीच घुसकर युवक ने की मारपीट

16, 31 जनवरी (जनसत्ता)।

नागरिकता संशोधन कानून (सीएए) के विरोध में प्रदर्शन कर रहे लोगों से ट और उनपर हमले के मामले बढ़ते ही जा रहे हैं। बीते रोज दिल्ली के जामिया एए के विरोध में प्रदर्शनकारियों पर एक नाबालिग युवक ने देसी पिस्तौल से चला दी थी। यह मामला अभी शांत भी नहीं हुआ था कि आज चंडीगढ़ के 29 स्थित मस्जिद में नमाज अदा करने के बाद ट्रहसिटी ज्वाइंट एक्शन ग्रुप के बैनर तले मुस्लिम और अन्य समुदायों के लोग सीएए और एनआरसी रोध में प्रदर्शन कर रहे थे कि अचानक एक युवक प्रदर्शनकारियों के बीच में र उन्हीं के साथ भिड़ गया। इस युवक ने पहले प्रदर्शन कर रहे लोगों के साथ करना शुरू कर दिया और देखते ही देखते मामला मारपीट तक जा पहुंचा। कि वहां मौजूद पुलिस कर्मियों ने आरोपी को गिरफ्तार कर लिया। आरोपी की न सेक्टर 29 निवासी विजय राणा के रूप में हुई है। आरोपी पेशे से सेक्टर 31 ग्रेन मार्केट में सब्जी बेचने का काम करता है। पुलिस ने आरोपी को एम के समक्ष पेश किया जहां पर उसे जमानत पर छोड़ दिया गया।

सब्सिडी, सेवा-मुक्ति लाभों के लिए 427 करोड़ जारी

चंडीगढ़: पंजाब के मुख्यमंत्री कैप्टन अमरिन्दर सिंह की हिदायतों पर विभाग द्वारा पंजाब राज्य बिजली कोर्पोरेशन (पी.एस.पी.सी.एल.) को सी सब्सिडी, केंद्रीय स्पांसर स्कीमें, पी.आर.टी.सी. और 15 नवंबर, 2019 तक सेवामुक्त हुए मूलजिम्मेदारों को सेवामुक्ति लाभों की अदायगी के लिए करोड़ रुपए जारी किये गए हैं। इस संबंधी जानकारी देते हुए मुख्यमंत्री लय के प्रवक्ता ने बताया कि किसानों को दी जाने वाली कृषि सब्सिडी नए पावरकॉम को 100 करोड़ रुपए जबकि 15 नवंबर, 2019 तक मुक्त हुए मूलजिम्मेदारों को जी.पी.एफ. /लोन एनकैशमेंट समेत सेवामुक्ति की अदायगी के लिए 163 करोड़ रुपए जारी किये गए हैं।

किसानों की नींद के

एकड़ की न में टिड्डी 1990 में तब उसे निलयंत्रण में व्यस्त थे। कृषि विभाग के ही एक सुपरवाइजर मनोज कुमार ने बताया कि 'यहां पर गांव के नाम वहां से गुजर रही नहरों के नाम पर रखे गए हैं। इसलिए इनके नाम 4वी, 24 एच, 2एक्स, 3एक्स आदि हैं। कल इन गांवों में भी टिड्डी दल ने हमला किया था।' पंजाब से सटे इन गांवों में टिड्डी दल से तबाह हुई फसल की वजह से पंजाब के किसान चिंतित हैं। पंजाब के कालेर खेरा गांव के किसान राजपाल औलख ने बताया कि 'पिछले हफ्ते ही हमने इस गांव में टिड्डी दल को देखा था। इसलिए हम बहुत चिंतित हैं।' करनपुर में कृषि विभाग के सहायक निदेशक राजपाल झाझरियाल ने बताया कि 'जनवरी के पहले हफ्ते से ही हमने करनपुर क्षेत्र के 24 एच, 47 एफ, 54 एफ और 12 एफ में टिड्डी दल के खात्मे के लिए अभियान चलाया था। वहां हमने 25 लाख से भी अधिक टिड्डियां मार दी थी। 24 एच गांव में तो खेतों में मरी हुई टिड्डियों के ढेर लगे हुए थे। उन्होंने कहा कि मार्च में प्रजनन सीजन के कारण इन टिड्डियों की आबादी बढ़ने की आशंका है। इसलिए हम उससे पहले ही इन्हें खत्म कर देना चाहते हैं ताकि यह पंजाब की ओर न बढ़ें।'
