In continuation to our letter dated 31<sup>st</sup> July 2023 on NGT judgment regarding Suo Motu case filed against the industries at Manali location (including the Company) in relation to an environmental issue for the period from April 2019 to December 2020, where NGT directed for collection of environmental compensation and creation of corpus fund for improvement of environmental standards in Manali Industrial area. The Company filed a writ petition against the said direction with Hon'ble High court of Madras and obtained a stay order.

In this connection, we are in receipt of copy of judgement on 29<sup>th</sup> March 2024 pronounced by Hon'ble High Court of Madras vide its order dated 14<sup>th</sup> March 2024 in relation to the writ petitions filed by the Industries at Manali including the Company, quashing the Direction no. 18 of para 53 of the judgment dated 20.07.2023 passed by National Green Tribunal (NGT), Southern Zone, Chennai, with regard to the creation of Corpus fund with the contributions by way of deposit of minimum 01% of the annual turnover by all Companies located in the Manali complex.

We wish to reiterate that there are no environmental compensation levied on the Company as we are in adherence to the prescribed environmental norms.

We request you to kindly take the above on record.
