Brief details of litigation	The Company has filed a review petition against the order / judgment dated July 23, 2021, in the AGR matter, whereby the clarification/ modification applications filed by the TSPs for correction of errors were dismissed by the Hon'ble Supreme Court. The Review Petition is pending before the Hon'ble Supreme Court of India for hearing and final disposal.
		Also on October 17, 2023, Company has filed Curative Petition in Hon'ble Supreme Court against the Review order dated January 16, 2020 in AGR matter, which is pending before the Hon'ble Supreme Court of India for hearing and final disposal.
2.	The details of any change in the status and/ or any development in relation to such proceedings	Department of Telecommunication (DoT) has issued the 'Revised Demand cum show cause notice' vide its communication i) CCA /MH /Comm /SUC /TTML /GSM & CDMA/10-11 dated/10/2023 received on 01/11/2023 and ii) CCA / MH /Comm /SUC /TTML /GSM & CDMA /09-10 dated 13/10/2023 received on 19/10/2023 has revised the SUC demand dated 15/11/2019 from Rs. 54.66 Cr to Rs. 47.80 Cr for FY 2010-11 and SUC demand dated 15/11/2019 from Rs. 27.03 Cr to Rs. 35.49 Cr (interest updated till Oct 2023) for FY 2009-10 respectively. The Company has been given 21 days to respond.
		Since these demands are for the period covered in the Hon'ble Supreme Court's judgement dated 01.09.2020, Company believes there is no negative financial implication expected. The Company will represent to DOT accordingly.
