- (c) Notice of **37th AGM of the Company** containing the resolutions to seek shareholders' approval for adoption of Annual audited Results for the FY 2022-23, Confirmation of payment of Interim Dividend as Final Dividend for FY 2022-23, Re-appointment of two Directors liable to retire by rotation, appointment of two Independent Directors of the Company and removal of Sh.
