Sirs,

We, ZF Steering Gear (India) Limited (**the Company**), intimate that –

- (a) As reported earlier the Members of the Company, in their Extraordinary General Meeting held on 17<sup>th</sup> July, 2019 approved the proposal of sale of 12,93,50,000 equity shares of Rs.10 fully paid up and acquired for consideration in cash, by the Company, in the share capital of Robert Bosch Automotive Steering Private Limited (**RBASPL** for brevity).
- (b) The Company sold and transferred the said shares of RBASPL to Robert Bosch Automotive Steering GmbH, Germany, (**Bosch**), as per the Agreement dated 28<sup>th</sup> May, 2019 and received the consideration of Rs.62,50,00,000.
- (c) Simultaneously, Mr. Dinesh Munot, the director, nominated by the Company, on the Board of Directors of RBASPL, resigned from the Directorship of that company, as agreed.
- (d) With this transaction RBASPL ceases to be an “associate company” of the Company.


