Governor discusses promotion of Hindi with Padmashree awardee C. Kamlova



AIZAWL, AUG 7—Governor Dr. Hari Babu Kambhampati invited C. Kamlova, a Padma Shree Awardee and a pioneer of Hindi language teaching in the state at the Raj Bhavan, today. The two shared their views and discussed how Hindi can be promoted in the state with new vigour in Mizoram. In this meeting, Governor asked about the standard of Hindi learning through various stages in the schools here in Mizoram. He also stressed the need and the potential benefits of enhancing the speaking skills of the youth of Mizoram in Hindi. Governor felt that the youth of Mizoram are talented and have the potential to secure lucrative jobs anywhere in India but they need to sharpen their Hindi speaking skill. He also shared his observation that, unlike some parts of India, the Mizo youth are not against learning the Hindi Language. C.
