## Family of 3 found dead in Vadodara; probe begins

A FAMILY of three, including a seven-vear-old child, allegedly died by suicide due to financial crisis in Waghodia road area of Vadodara Monday, after which Panigate police station began a probe.

According to police, Pritesh Mistry, his wife Sneha and son Harshil were found dead Monday morning by Pritesh's mother who came to their house.

According to Pritesh's friend Kunal Chunara, Mistry sent a text message to his mother Sunday night asking her to come over to their residence Monday morning for a lunch outing. However, when she reached, doorbell or phone calls were not answered.

She then entered the house through the backdoor only to

and indicated about a note in his mobile phone, which the police are trying to extract.

Chunara told reporters, "As far as we know, Pritesh was well settled. He used to trade in stockmarket and was into electronics business as well. He had even purchased a new luxury car recently... It is possible he ran into financial trouble, as his note indicates.'

Vadodara Deputy Commissioner of Police, Zone III, Yashpal Jaganiya said, "We have initiated a probe and sent the bodies to SSG Hospital for postmortem... In his note on the wall he mentioned financial crisis... The note from his mobile phone is also being extracted with the help of FSL.

Police added that a probe will also ascertain if Mistry had first killed his son and wife before

### Wife and two friends detained over man's murder in Ahmedabad

POLICE HAVE detained a woman and her two friends over the murder of her husband after his body was found in a well in a farm in the Kathwada area in Nikol in Ahmedabad.

According to an FIR registered at Nikol police station, 10 days ago when he was on a trip to Rajasthan, Mahesh alias Mayur Lakkad (28) told his father that his wife, Miral Lakkad (25), was having an affair with Anas Mansuri alias Lalo Baubhai (21). The duo, along with their mutual friend Khushi, allegedly threatened to kill Mayur if he told anyone about the affair.

Mayur was supposed to reach his father's village at Virdi in Amreli with his two sons on January 5. However, as Mayur did not come and his phone was not reachable, his father called Miral. But the call was picked up by Khushi, who told him that Mayur had been called by Mansuri and that the children were with Miral.

However, Mayur's father sent three relatives to the house of his son's in-laws, where they found Miral, her father and Mansuri. They told the relatives that Mayur went somewhere in the night and that they were

also searching for him. However, after his father

lodged a missing complaint, the three accused admitted to the murder, according to police.

After Mayur's body was found, a case was registered at the Nikol police station. Mansuri allegedly slashed Mayur's throat multiple times and dumped his body in a farm well in Kathwada area.

The three have been booked under Indian Penal Code sections 302 (murder), 201 (causing disappearance of evidence of offence, or giving false information to screen offender), 120B (criminal conspiracy), 506 (2)(criminal intimidation) and under a section of the Gujarat Police Act.

Investigating officer KD Jat told The Indian Express that Mansuri took Mayur away to talk about his affair with Miral when he was about to leave for his father's village.

Khushi and Mansuri have been friends for four years, and Miral and Khushi for the past one year. It was through Khushi that Mansuri and Miral became friends two months ago, according to Jat. "All the three knew each other through Instagram," he said.

"We have detained them. The three will be arrested this (Monday) evening after they test negative for Covid-19,"

## Suo motu PIL on ragging in colleges: HC issues notice to education dept

TRAINING ON LAW ENFORCEMENT

THE GUJARAT High Court on Monday issued a notice to the

state education department in a suo motu PILon "ragging menace" after considering a recent news report about an incident at a medical college in Vadodara. The division bench of Chief

Justice Aravind Kumar and Justice Ashutosh Shastri issued a notice to the additional chief secretary of the state education department.

The court also issued notices to the commissioners of Higher Education, Technical Education, and Health, Medical Services and Medical Education.

"A communication was addressed to one of us (chief justice) by a sitting judge of this court highlighting the issue of ragging menace occurring in the state of Gujarat by enclosing a newspaper report." the court said.

Considering the said menace as reported in the newspaper on January 3, 2023, it was of the view that the concerned departments should be called for steps taken to contain the same, while issuing notices returnable on January 30, the court said.

The news report was regarding three senior resident students of a private medical college in Vadodara being suspended by the college administration for allegedly ragging a junior student.

The action came after the father of the victim filed a complaint on finding that his son had left home to commit suicide due to depression after being ragged and was rescued from a railway station. As per the news report, senior students were accused of abusing him in public, extorting money and compelling him to carry out their errands.

Junior residents of an Ahmedabad-based medical college had similarly registered a ragging complaint last month.
