**SUMMARY OF PROCEEDINGS OF THE 67<sup>TH</sup> ANNUAL GENERAL MEETING OF THE STATE TRADING CORPORATION OF INDIA LIMITED**

The 67<sup>th</sup> Annual General Meeting of the State Trading Corporation of India Limited was held on Thursday, September 21, 2023 at 11:30 A.M. through Video Conference.

**Members Attendance**

44 shareholders including the representative of the Government of India (holding collectively 54001988 shares – 90.00 %) attended the meeting through Video Conference.

Statutory registers and records as per the Companies Act, 2013 were made available for inspection by Shareholders.

Shri Hardeep Singh, Chairman and Managing Director chaired the meeting.

Shri Kapil Kumar Gupta, Director (Finance), Shri Satish Kumar Chawla, Independent Director & Chairman of the Audit and CSR Committee, Shri Divakar Shetty Kaup, Independent Director & Chairman of the Stakeholder Relationship Committee, Dr. Bhim Singh, Independent Director & Chairman of the Nomination & Remuneration Committee and Shri B. S. Rao, Chief Financial Officer were also present during the Meeting.

Upon confirmation by the Company Secretary that the quorum was present, the Chairman called the meeting to order and the proceedings of the meeting commenced.

The Chairman of the meeting welcomed the shareholders and delivered his speech. With the consent of all the Members present, the notice of the AGM and the Directors Report were taken as read.

The Company Secretary informed the Members that as per Section 108 of the Companies Act, 2013 read with Rules 20 of the Companies (Management and Administration) Rules 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation 2015, the Company had provided e-voting facility to its members to exercise their right to vote by electronic means from September 18, 2023 (09.00 A.M) to September 20, 2023 (05.00 P.M). The facility of e-voting was made available for such members at the AGM, who could not exercise their vote through remote e-voting process.
