## **Business Update**

## <u>Purchase of Solar Power from Amplus RJ Solar Pvt. Ltd. ("Amplus").</u>

**New Delhi, 30<sup>th</sup> December, 2022**: Gulshan Polyols Ltd (Gulshan), a multi-location, multi-product manufacturing company with global presence in 35+ countries, across 3 continents, wish to announce the collaboration with Amplus, incorporated in India, a subsidiary company of a Singapore based Company, to purchase electricity in the form of solar energy for our Muzaffarnagar plant in Uttar Pradesh.

- Gulshan in association with Amplus has initiated to purchase solar energy. This association
  would facilitate supply of power for Muzaffarnagar plant, which is mainly focused on grain
  processing and mineral processing business.
- Gulshan expects to procure 4 to 5 Lakhs units of electricity per month at 30-40% subsidized cost through this association for Muzaffarnagar plant in Uttar Pradesh.

On the financials front, this association will enable us to smoothen out and reduce energy costs which have got impacted due to crises of availability of fossil fuels at higher cost.
