## गुन्हेगारांनो खबरदार! लेडी सिंघमची एन्ट्री; वाहतूक विभागाच्या पहिल्या महिला अधिकारी

**नागपूर :** शहर पोलिस वाहतूक विभागाच्या इतिहासात पोलिस आयुक्तांनी पहिल्यांदाच झोनचे प्रमुखपदावर एका महिला पोलिस अधिकाऱ्याची नियुक्ती केली आहे. आशासला खापर असे नियुक्ती मिळालेल्या महिला पोलिस निरीक्षकाचे नाव आहे. त्यांना सककरदरा वाहतूक झोनची जबाबदारी देण्यात आली आहे.

आशासला खापर या मुळच्या पुण्याच्या आहेत. गेल्या काही महिन्यांपूर्वीच त्यांची नागपूर शहर पोलिस दलात बदली झाली होती. पोलिस आयुक्त डॉ. भूषणकुमार उपाध्याय यांनी आशासला यांची नेमणूक वाहतूक खांबेत केली.

पोलीस उपायुक्त विक्रम साळी यांनी आशासला यांच्यावर विश्वास टाकत अपघात सेलची जबाबदारी दिली. त्यांनी शहरात होणाऱ्या अपघात ठिकाणांचा अभ्यास केला. अपघात स्थळांची माहिती गोळा केली. अपघात ठिकाणांचा सर्व्हे करून ब्लॅक स्पॉट निश्चीतीकरण



केले. शहरातील अपघात कमी करण्यासाठी या सर्व्हेचा उपयोग करण्यात येत आहे.

तसेच त्यांना कोर्ट सेलचीमुद्दा जबाबदारी देण्यात आली होती. त्यांनी कोर्टात सुरु असलेल्या केसेस आणि दंडात्मक कारवाईत सुधारणा करण्यासाठी बरीच मेहनत घेतली. गेल्या १९ ऑगस्टला त्यांच्याकडे सककरदरा झोनचा पदभार देण्यात आला. वरिष्ठ पोलिस निरीक्षक महेश चव्हाण यांची बजाजनागर पोलीस ठाण्यात बदली झाली. त्यांच्या रिक्त जागी आशासला खापर यांची नियुक्त

करण्यात आली. आशासला यांनी सण-उत्सवाचा बंदोबस्त, व्हिआयपी बंदोबस्ताची जबाबदारी योग्यप्रकारे पार पाडली. अपघाताच्या संख्येमध्ये घट आणि ई चालानामध्ये वाढ करण्यासाठी यशस्वी प्रयत्न केले. वाहतूक विभागात पहिल्या महिला अधिकारी म्हणून नव्याने जबाबदारी देण्यात आली आहे.

## नागपुरातील सिटी बसेसची भंगारकडे वाटचाल

**नागपूर :** राज्यात मुंबई, पुणे, नाशिकसह अनेक शहरात सिटी बसेसचे संचालन सुरु झाले आहे. एसटी महामंडळानेही १८ हजार बसेस रस्त्यावर आणल्या आहेत. परंतु नागपूर शहर बसेस सेवा सुरु करण्याची प्रतीक्षा अजूनही सुरु आहे. आता परिस्थिती अशी झाली आहे की उभ्या असलेल्या ६० टॅके बसेसचे टायर व बॅटरी खराब झाली आहे. वेळीच बसेसवा सुरु झाली नाही तर सिटी बसेस भंगार झाल्याशिवाय राहणार नाही.

नागरिकांच्या हितासाठी शहर बसेसवा सुरु होणे गरजेचे आहे. नागरिकांचे म्हणणे आहे की, इतर शहरात बसेस सुरु झाल्या आहेत. जिल्हातर्गत एसटी बसेस धावू लागल्या आहेत, तर नागपूर शहरात बसेसवा सुरु करण्यास अडचण कसली. मनपातील काही अधिकाऱ्यांमुळे संपूर्ण शहर अडचणीत आले आहे. राज्य सरकारला आता यात हस्तक्षेप करण्याची गरज आहे. राज्य सरकारने जेव्हा अधिकार दिले, तेव्हा बसेस संचालनाचे निर्देशमुद्दा देऊ शकतात.

परंतु मनपाचे अधिकारी स्वतःला राज्य सरकारच्या वर मानत आहे. शहर बसेसेवत ४३२ रेड बस, ५ इलेक्ट्रिक बसेस आहेत. आणखी ४० इलेक्ट्रिक बसेस सहा महिन्यात मनपाला मिळणार आहेत. शहर बसेसेवत कार्यरत तीन हजार कर्मचारी सहा महिन्यांपासून वेतनापासून वंचित आहेत. महिनाभरात बसेसवा सुरु न झाल्यास शहर बसेसेवचे अस्तित्त्व धोखाटत येऊ शकते.

**एसटी सुरु झाली, सिटी बस का नाही?**

राज्यात जिल्हातर्गत एसटी बसेस सुरु झाल्या आहेत. प्रवासीदेखील उपलब्ध होत आहेत. सुरक्षा नियमाकडे लक्ष ठेवून आवागमन सुरु झाले आहे. राज्यात १८ हजार एसटी बसेस रस्त्यावर धावत आहेत. दिल्लीत १५ हजार सिटी बसेस धावत आहेत. मुंबई, पुणे, नाशिक शहर जेव्हा संक्रमण वाढत होते, तेव्हाही बसेसचे संचालन सुरु होते. सध्या मुंबईत संक्रमण कमी होत आहे. नागपूर शहरात बसेसवा सुरु होत नसल्यामुळे गरीब व मध्यमवर्गीयांना त्रास होत आहे.

**नागपूर :** नागपूर महापालिकेचे बहुचर्चित आयुक्त तुकाराम मुंढे यांची राज्य सरकारने बदली केली असून त्यांच्या जागी बी. राधाकृष्णन यांची नियुक्ती करण्यात आली आहे.

मुंढे यांची बदली अपेक्षित नव्हती. पर्यावरणमंत्री आदित्य ठाकरे हे पण त्यांच्या कामावर खूष होते. मुख्यमंत्री उद्धव ठाकरे यांनीही त्यांच्या कामाला पाठिंबा दिला होता. नागपूर स्मार्ट सिटीच्या व्यवस्थापकीय संचालकपदाचा कार्यभार स्वीकारण्यास नागपूरचे महापौर संदीप जोशी यांनी मुंढे यांना अडचणीत आणण्याचा प्रयत्न केला होता. तसेच केंद्रीय मंत्री नितीन गडकरी यांनीही मुंढे यांची तक्रार थेट केंद्रीय नगरविकास

विभागाकडे केली होती. कोरोनाची स्थिती हाताळण्यावरून मुंढे यांचे स्थानिक नेतृत्वाशी खटके उडत होते. मात्र सामान्य जनता त्यांच्यावर खूष होती. तरीही त्यांची बदली झाल्याने आश्चर्य व्यक्त होत आहे.
