India reports 2,364 new cases, 2,582 recoveries in 24 hours



New Delhi: In the last 24 hours till Thursday 7am, India registered 2,364 new Covid-19 cases, whereas 2,582 patients recovered, taking the tally of recovered patients, since the beginning of the pandemic, to over 4.25 crores in the country.

Total number of active Covid-19 patients in the country 15,419, this comprises approximately 0.04% of the total cases registered since the beginning of the pandemic.

According to the Ministry of Health and Family Welfare, more than 4.77 lakh tests were conducted in the last 24 hours taking the cumulative tests conducted, since the beginning of the pandemic, to over 84.54

Recovery rate, at a consistent pace, currently stands at 98.75%. Weekly Positivity Rate in the country currently stands at 0.55% and the Daily Positivity rate currently stands at 0.50%.
