Dear Sir,

I, Shirin Bhatt, Practicing Company Secretary (Membership No. F8273/ C.P. No. 9150) appointed as Scrutinizer by the Board of Directors of the Company vide resolution dated **26**th **October**, **2023** for the purpose of scrutinising and ascertaining the requisite majority of the votes cast in the Postal Ballot conducted via remote e-voting (the "Postal Ballot") held between **09.00** AM on Saturday **4**th November, **2023** and ended on IST **05.00** PM on Sunday **3**rd December, **2023**, being undertaken under Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 and relevant MCA Circulars, on the resolutions contained in the **Postal Ballot Notice** of the Company dated **26**th **October**, **2023**.

We submit our report as under:

- 1. The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013, Rules thereunder read with relevant MCA Circulars, Secretarial Standards on General Meetings (SS-2) and regulations contained in the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to voting through electronic means on the resolutions contained in the Postal Ballot Notice.
- 2. The responsibility as a scrutiniser for the remote e-voting is restricted to the extent of **preparation and presentation of Scrutiniser's Report of the votes cast "FOR" or "AGAINST"** on the resolutions stated in the Notice, based on the reports generated from the e-voting systems provided by the KFin Technologies Limited (the **"KFin"**) at https://evoting.kfintech.com/ the authorized agency to provide e-voting facilities.
- **3.** The voting rights were reckoned as on **Friday**, **27th October**, **2023**, being the cut-off date for the purpose of deciding the entitlement of members to vote at the remote e-voting.

- 4. The Company appointed KFin, also the Registrar and Share Transfer Agent of the Company, as a service provider for extending the facility of providing remote electronic voting to the Shareholders of the Company from 4th November, 2023, Saturday, 09.00 a.m. till 3rd December, 2023, Sunday, 05.00 p.m. The remote e-voting platform was blocked after 05.00 p.m. on 3rd December, 2023. The votes cast at remote e-voting were unblocked in the presence of following two witnesses not being in the employment of the Company as under and then tabulated:
 - (a) Mrs. Preeti Chauhan (1st Witness)
 - (b) Mr. Ajay K Sirohi (2nd Witness)
- **5.** Results of remote e-voting forms part of this report and are attached as **Annexure-A** to this report and based on these reports I report that Item no. 1 and 2 of the Postal Ballot Notice stands passed as Special Resolutions with 3/4th majority of votes cast in favour of the resolutions.
- **6.** The electronic register and all other papers and relevant documents relating to remote evoting, shall remain in our safe custody until the Chairman considers, approves and signs the minutes. Thereafter the said documents shall be handed over for safe keeping to Mr. Ashish Kumar, Group Company Secretary & Compliance Officer of the Company.

You may accordingly declare the result of postal ballot by remote e-voting.
