On the above subject matter, pursuant to the provisions of Regulation 30 of SEBI Listing Regulations, we would like to inform that the Joint Commissioner (ST), Secunderabad Division, Hyderabad vide its Proceedings dated 09.01.2024 confirmed the short levy of tax of Rs. 4,35,60,832, being the tax (CST) on the difference of turnover between TINXSYS data vis-à-vis the actual turnover for the Assessment Year 2015-16.

In this regard, the Company would like to clarify that the CST as above has been demanded by the department primarily on the branch transfers, which does not attract any tax liability (as the Company has already filed total F-forms with the Department). The Company in consultation with its Solicitors, would be filing an appeal before the appropriate authorities in due course of time.

The details as required under SEBI Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD1/P/CIR/2023/123 dated 13th July, 2023 are enclosed in Annexure 1.
