As per the provisions of the SEBI Master Circular no. SEBI/HO/DDHS/DDHS-POD2/P/CIR/2023/111 dated July 03, 2023 relating to Credit Rating Agencies, we would like to inform you that voluntary disclosure of Long-Term Issuer Rating of Jubilant Agri and Consumer Products Limited (hereinafter referred to as "JACPL"), a wholly-owned subsidiary of the Company, has been withdrawn. Furthermore, as JACPL currently has no plans to raise funds through the issuance of commercial paper, the Credit Rating for its Commercial Paper limits has also been withdrawn.

We would like to further inform you that M/s. India Ratings and Research Private Limited, a Fitch Group Company, has vide its communication dated September 21, 2023, reaffirmed/assigned the credit ratings on the debt facility (ies) availed/to be availed by JACPL as follows:
