During the previous quarter the company reassessed the benefits of opting for tax regime permitted under section 115BAA of Income Tax Act, 1961 as introduced by the Taxation Laws (Amendment) Ordinance, 2019. Accordingly, the Company has recognized the provision of income tax for the period ended September 30, 2022 as per the new tax rate and remeasured its differed tax basis the rate prescribed in the aforesaid section. The total consequent impact of remeasurment of Deferred Tax amount to INR 170.05 Million and accordingly proportionate amount is accounted in the half year ended September 30, 2022.
