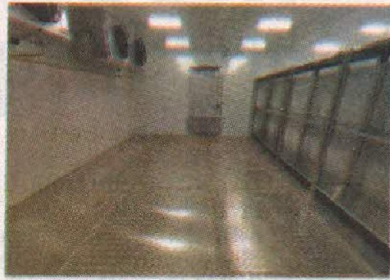

Udupi district readies walk-in cooler for storing Covid vaccine

EVEN as efforts are going on to launch a Covid-19 vaccine as soon as possible by next year, the World Health Organization (WHO) has instructed countries to prepare a system to ensure that storage facilities are in place before launching the vaccine drive. Udupi district administration which succeeded in containing the spread of the infection by going for a robust testing and isolation mechanism, has now come up with a walk-in cooler to safely store vials when the vaccine drive is launched.

The walk-in cooler is being readied at the office of district health

and family welfare department near Brahmagiri and it has the capacity to store 2.28 crore doses of vaccine. The room where the walk-in cooler has been set up is fully air conditioned. Udupi DC G Jagadish said

those in the health sector who are working as frontline warriors in the fight against COVID-19 will be given the vaccine on priority and a database of them is being readied in the district. DHO Dr Sudhirchandra Sooda said that vaccine is required to be kept strictly between two and eight degrees Celsius from the stage of sourcing it, during the transportation and till the stage of distribution. To ensure this, there are already 77 cold chain points identified in the district. 1,324 vehicles and 9,370 ice packs are also on standby mode. An expert staff who can administer the vaccine have also been shortlisted in the district, Dr Sooda added.

The health department is not facing such a problem in the other districts as there are lesser number of private medical establishments there. "Details of all health care workers in 106 government health facilities have been filled in the data template and submitted. It is only private medical establishments such as small clinics, medical colleges with over 3,000 employees each, nursing colleges, who are yet to give the data. The deadline was October 29, but we have now extended it, so that more health care workers fill it, right from doctors to Group-D workers," said an official who was present at the meeting. At present, only 13 per cent of private facilities and five out of six medical colleges in the city have submitted their details. There are nine categories of health care workers, including frontline health workers, nurses and supervisors, medical officers, paramedical staff, support staff, students, scientists and research staff, clerical and administrative staff and other health staff who are being prioritised for vaccination. The frontline workers include Accredited Social Health Activist (ASHA) workers, Auxiliary Nurse Midwives (ANMs) and Anganwadi workers.
