Report on the Audit of Standalone Financial Results

**Opinion**

We have audited the accompanying Statement of Standalone Financial Results of Jay Bharat Maruti Limited ("the Company") for the quarter ended 31<sup>st</sup> March, 2023 and year to date results for the period from 1<sup>st</sup> April, 2022 to 31<sup>st</sup> March, 2023 ("the statement") attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015, as amended ("the Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us, these Standalone Financial Results:

**Basis of Opinion**

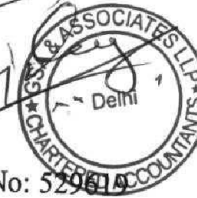

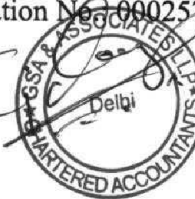
