## Sale/dilution/transfer/disposal of 100% stake in Material Subsidiaries

Pursuant to the share purchase agreements entered into by KNR Constructions Limited ("the Company"), Material wholly owned subsidiaries (KNR Shankarampet Projects Private Limited, KNR Srirangam Infra Private Limited and KNR Tirumala Infra Private Limited) and Cube Highways and Infrastructure III Pte Ltd. and pursuant to the concession agreement and as amended by the Ministry of Road Transport and Highway's Office Memorandum No. 24028/14/2014-H (Vol. II) dated 10 November 2020, and Circular No. NH-24028/14/2014-H (Vol. II) dated 27 November 2020, the MoRTH Circulars wherein the NHAI has permitted transfer of 49% of stake on the date of receipt of Provisional Certificate (PCOD/COD) and the balance 51% shares held by the Company in the material wholly owned subsidiaries will be undertaken after 6 months from the date of receipt of PCOD/COD subject to obtaining a noobjection certificate from the consortium of lenders of material wholly owned subsidiaries, and from the NHAI. The above transfers will also involve a transfer of control of the material subsidiaries.
