With reference to the captioned subject and pursuant to Regulation 30 read with Para A of Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, (SEBI LODR) details with respect, as required under Regulation 30 of the SEBI LODR read with SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023, are disclosed.

Please note, the erstwhile workers/workmen of Crompton Greaves Limited had filed cases against it before the Hon'ble Court alleging unfair trade practices and sought back-wages/damages along with reinstatement of their employment.

By virtue of a scheme of arrangement entered between Crompton Greaves Limited and Crompton Greaves Consumer Electricals Limited, the consumer products business of the Crompton Greaves Limited got demerged from it and got merged into Crompton Greaves Consumer Electricals Limited. Post the said demerger, Crompton Greaves Consumer Electricals Limited's name was added as a party to the on-going cases filed by the erstwhile workers/ workmen of Crompton Greaves Limited.

In the said cases, the Hon'ble Labour Court passed orders whereby workers/workmen were allowed compensation of such amount as specified in the said orders, to be paid by the Crompton Greaves Consumer Electricals Limited.

Pursuant to the above the Company has received below orders on August 28, 2023 at 12.30 P.M.. The details of the orders received are specified in Annexure-A enclosed herewith.
