 - (ii) On 11.12.2020, allotted **19,32,36,714** equity shares of face value of Rs.10/- each at an Issue Price of Rs.103.50 (including premium of Rs.93.50) per share aggregating up to Rs 2000 Crores to eligible qualified institutional buyers, in accordance with the applicable provisions.
- c) The Securities and Exchange Board of India (Substantial Acquisition of Shares and Take over) Regulations 2011
- d) The Securities and Exchange Board of India (Buyback of Securities) Regulations, 2018
