

# नाम नूर काजी निकला तो वोट बैंक की चिंता हो गई

यूपी के पूर्व सीएम अखिलेश यादव इन दिनों मध्य प्रदेश में सपा उम्मीदवारों के समर्थन में प्रचार कर रहे हैं। इसी दौरान एक पत्रकार के सवाल में 'टोटी चोर' शब्द सुनते ही वे भड़के गए। सवाल पूछने वाले को 'गंदा पत्रकार, भाजपा का एजेंट, बेटा' जैसे विशेषणों से नवाजने लगे। लेकिन जब पत्रकार का नाम नूर काजी होना पता चला तो शायद सपा सुप्रीमो को वोट बैंक की चिंता होने लगी। लिहाजा डैमज कंट्रोल की कोशिश करते हुए 'आप मुस्लिम हो, मुस्लिमों की भाषा ऐसी होती है' जैसे वाक्यों पर आ गए। फिर पत्रकार की निंदा सामंतवाद, मनुवाद से लड़ाई पर आकर थमी। इस घटना का वीडियो सोशल मीडिया में वायरल है। घटना गुरुवार (9 नवंबर 2023) की है। अखिलेश यादव मध्य प्रदेश के पन्ना से सपा उम्मीदवार महेंद्र के समर्थन में जनसभा करने अजयगढ़ पहुंचे थे।

## पत्रकार को बताया अपराधिक किस्म का संदिग्ध व्यक्ति
