and based on the above examination, we hereby report that, during the Review Period:

However, in the year 2015 the Adjudicating Officer of SEBI has passed an order imposing penalty of Rs.21.25 Lacs against all promoter entities of BCMA some of them are promoter entity of Walchandnagar Industries also, with reference to purchase of shares of BCMA by Walchand Kamdhenu Commercials Pvt. Ltd. This matter is currently pending in Supreme Court of India.
