**Sub: Combined Report on Remote e-voting and voting by Ballot conducted at the 60th Annual General Meeting of Modella Woollens Limited.**

- 1) I, Upendra C. Shukla, Practicing Company Secretary, was appointed as the Scrutinizer by the Company to scrutinize the electronic voting process. I was also appointed as scrutinizor to scrutinizor the voting by means of Ballot at the 60th Annual General Meeting (AGM). The said appointment was for ascertaining the requisite majority on e-voting as also on Ballot carried out for the resolutions proposed to be passed at the 60th AGM of the Shareholders of the Company, held on Wednesday, the 28th September, 2022.
- 2) As per the provisions of Section 108 of the Companies Act, 2013 read with the Rule 20 of the Companies (Management and Administration) Rules, 2014 as also Regulation 44(1) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided the facility of e-voting to the Shareholders to cast their votes electronically on all the resolutions proposed in the notice of 60th Annual General Meeting.
- 3) In line with the provisions of the Companies Act, 2013 and in term of the clarifications issued by MCA, voting by show of hands is not permitted at the general meeting where e-voting has been offered to the Shareholders. Therefore, at the 60th Annual General Meeting of the Company, voting was announced by the Chairman and was conducted by means of Ballot.
- 4) M/s. Purva Sharegistry (India) Pvt. Ltd., the Registrar and Share Transfer Agents of the Company, provided all the requisite data of shareholders eligible for voting.
